All fees for the Nursery are exempt from VAT. Early Years Funding is available for each eligible pupil attending the. Nursery (see fees below).

Please note:

Fees are due on or before the first day of each term.

A full terms' notice is required in writing prior to withdrawing a pupil. This means **written** notice given not later than the final day of the term before the term preceding the term to which the notice relates. For example, a term's notice is required to withdraw your child from the School. So, if you wish to withdraw your child with effect from the start of the Summer Term, a term's notice means you need to tell us in writing about the withdrawal, at the latest, on the last day of the Autumn Term immediately before. This is because the Summer Term is the term to which the notice relates.

Early Years Funding (Nursery and Reception Fees)

All 3 to 4 year olds are eligible for Early Years Funding (15 hours per week), this is not means tested or requires parents to apply for a code. Early Years Funding can be used on School fees up until (and inclusive of) the term in which a child turns 5 years old. For the Richard Pate School, funding is able to be claimed for 33 weeks of the academic year which is normally between 34 and 35 weeks long.

Agreed Additional Services Charges:

The local authority funding is set at a rate by the DfE and is only intended to cover the statutory requirements. The Richard Pate School offers exceptional education and care in its early Years and Foundation Stage which is over and above the statutory requirements. There is therefore an optional agreed additional services charge which covers the following items.

- Lunches prepared fresh daily in our kitchen and other snacks and drinks.
- Non-food consumables such as additional materials for personalised learning journeys, learning equipment / materials and additional art and craft materials.
- Activities and specialist teaching including: preparation of personalised learning journeys and end of year report, woodland / forest school sessions in the School's woodland, specialist Music in the main music school, specialist French, PE and movement in the main School Hall, Games and sports day on the field, productions in the Hall, cookery, Art, topic work activities, parent events and trips (all dependent on the day that your child attends).
